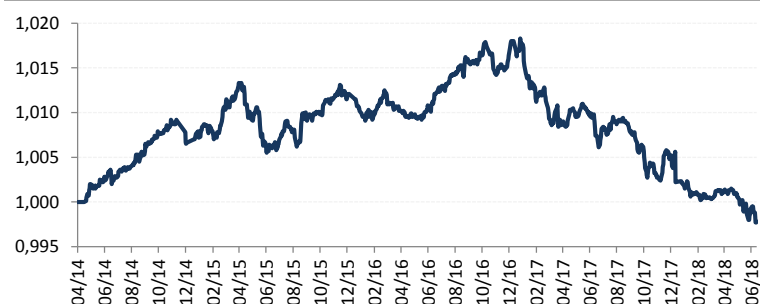

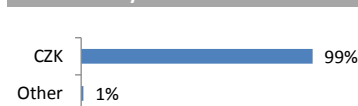

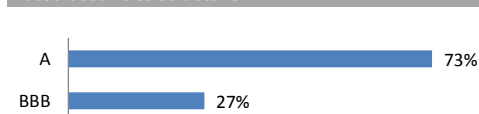
Recommended investment horizon
